Clean Water Certificate Program Overview

Get Hands-On Training for In-Demand Jobs in Green Stormwater

Are you seeking a rewarding career where you can make a difference for your community and the environment? The Clean Water Certificate (CWC) program can help you get started in the growing field of green infrastructure.

Training Program Participants & Instructors

The CWC Program provides training to **under and unemployed adults** seeking to reenter the workforce or those who wish to **expand existing knowledge base** and skillsets in order to transition to a new position in the stormwater industry.

The instructors are highly qualified industry professionals who possess a post-secondary degree in an environment-related field and/or work experience in the stormwater industry. All CWC instructors are required to complete their own training delivered by the Center for Watershed Protection, Inc.

Are there any pre-requisites for enrollment?

Participants must:

- 1. Be enrolled in a workforce development program, or be currently employed and recommended by an employer.
- 2. Have a demonstrated ability to perform the work through pre-screening or through an existing employer.

A high school diploma or GED is not required, and no special technology, equipment, or skills are necessary.

Certificate Details

Following the successful completion of the CWC Program, participants receive a Certificate of Completion. It does not have an expiry date.

Certificates may be provided to employers to demonstrate proficiency in skills and knowledge for entry-level jobs in the stormwater management industry.

What will I learn?



Introduction to Watersheds & Stormwater

Understand the need for stormwater management, the sources of pollution in urban areas, and the impacts on local waterways.



Types and Functions of Green Infrastructure:

Discover different types of green infrastructure systems, from rain gardens to green roofs, and understand their benefits and how they work.



Materials and Components:

Become familiar with the type of materials and the different components in these systems.



Construction and Equipment

Learn the basic steps of construction along with the different equipment you may encounter on a job site.



Identifying and Solving Maintenance Issues:

Learn to spot problems and implement solutions to keep green infrastructure systems functioning effectively.

Training Structure:

Participants will develop jobreadiness skills and knowledge of Green Infrastructure through participation in classroom and hands- on activities, as well as field-based experiences. Participants will be evaluated based on thier ability to engage with the concepts and vocabulary taught throughout the training.

How will I be evaluated?

Participants are evaluated by the CWC Instructor on a daily basis using a Rubric & Evaluation Form that was developed by the Center for Watershed Protection with input from a group of industry stakeholders. Participant performance, and therefore certificate issuance, is evaluated based on four (4) metrics.

- Attendance
- Demonstrated Knowledge in Action
- Demonstrated Knowledge in Verbal Communication
- Final Assessment

The CWC Program utilizes a unique evaluation system that goes beyond traditional testing, ensuring that individuals who may not thrive in traditional academic environments can still succeed.
